DIRECTIONS

MARC DEODORIZER is a highly concentrated product that may be dripped or sprayed in areas to be treated.

SEWAGE TREATMENT DRIPPING:

For best results, **MARC DEODORIZER** should be allowed to drip from the container directly into the sewage at the point that it enters the collection system. It should be dripped at the rate of one gallon **MARC DEODORIZER** to every 250,000 gallons liquid sewage. In extreme cases, amount should be doubled.

SPRAYING: For best results, mix one part **MARC DEODORIZER** to 50 parts water. Spray directly over sludge beds and trickling filters.

DRAINS: Pour one-half cup **MARC DEODORIZER** into drain at time of minimum use. Allow to remain overnight.

WET WELLS: Pour or spray undiluted **MARC DEODORIZER** directly into wet well.

DRAINAGE DITCHES OR STORM SEWERS: Dilute one gallon **MARC DEODORIZER** with 25 gallons water. Apply by hand sprayer or any pumping spray system. The amount required will depend on the amount of odor and degree of control desired.
