**MARC SHEEN** Dust Mop Treatment, when used in the care and maintenance of hard surface floors, helps maintain surface appearance by removing the dust and soils that can damage or scar floors or floor polish films. When properly applied to a dust mop, it will not leave oily residue on the floor and is easily washed from the mop in normal laundry procedures. It reduces airborne dust caused by sweeping with brooms and eliminates sweeping compounds. It can also be used on a dust cloth to dust furniture and other surfaces or sprayed on air filters to help attract and hold airborne dust, dirt and lint in the filter. **MARC SHEEN** Dust Mop Treatment contains special ingredients that convert dust to heavy lint which can be easily washed out.

#### DIRECTIONS FOR USE:

FOR BEST RESULTS: Remove the cap and hold the can 6 to 8 inches from a clean mop head. Treat the mop by applying a fine spray over the center of the mop head. Do not wet. Do not apply onto floor surface. Allow treatment to penetrate. Do not overuse. FOR USE ON A DUST CLOTH, apply a slight amount to face of cloth, fold and allow to "wick" throughout. FOR USE IN CONTROLLING AIRBORNE DUST AND LINT ON AIR FILTERS, spray a fine mist on filter. Do not overuse. FOR USE AS A BLACK HEEL MARK REMOVER, apply a slight amount to a rag and polish scuff marks before buffing. Never retreat soiled dust mops or cloths. Wash cloths and mops frequently and retreat to maintain effectiveness.

**DANGER:** Extremely flammable aerosol. Contains gas under pressure; may explode if heated. Causes serious eye irritation. May cause an allergic skin reaction. May be fatal if swallowed and enters airways. Keep away from heat, sparks, open flames, and hot surfaces. -No smoking. Do not spray on an open flame or other ignition source. Pressurized container: Do not pierce or burn, even after use. Protect from sunlight. Store in a well-ventilated place. Do not expose to temperatures exceeding 50°C/122°F. Wash hands thoroughly after handling. Wear eye protection and protective gloves. If in eyes, Rinse cautiously with water for several minutes. Remove contact lenses, if present and easy to do. Continue rinsing. If eye irritation persists: Get medical advice or attention. Avoid breathing mist, vapors or spray. Contaminated work clothing must not be allowed out of the workplace. If on skin: Wash with plenty of water. If skin irritation or rash occurs: Get medical advice or attention. Wash contaminated clothing before reuse. If swallowed: Immediately call a poison center or doctor. Do NOT induce vomiting. Dispose of contents and container in accordance with local, state, and federal regulations.

**PELIGRO:** Aerosol extremadamente inflamable. Contiene gas a presión; puede explotar si se calienta. Provoca irritación ocular grave. Puede provocar una reacción alérgica en la piel. Puede ser mortal en caso de ingestión y penetración en las vías respiratorias. Mantener alejado del calor, chispas, llamas abiertas y superficies calientes. -No Fumar. No rocíe sobre una llama abierta u otra fuente de ignición. Recipiente a presión: No perforar ni quemar, incluso después de su uso. Protéjase de la luz solar. Almacenar en un lugar bien ventilado. No lo exponga a temperaturas superiores a 50°C/122°F. Lávese bien las manos después de manipular. Use protección para los ojos y guantes protectores. Si entra en contacto con los ojos, enjuague cuidadosamente con agua durante varios minutos. Qúitese las lentes de contacto, si lleva y es fácil de hacer. Continúe enjuagando. Si la irritación ocular persiste: busque atención o consejo médico. Evite respirar neblina, vapores o aerosoles. No se debe permitir que la ropa de trabajo contaminada salga del lugar de trabajo. En caso de contacto con la piel: lavar con abundante agua. Si se produce irritación o sarpullido en la piel: busque atención o consejo médico. Lave la ropa contaminada antes de volver a usarla. En caso de ingestión: Llame inmediatamente a un centro de toxicología o un médico. No induzca el vomito. Deseche el contenido y el recipiente de acuerdo con las regulaciones locales, estatales y federales.
