DIRECTIONS FOR USE:

Shake Well Before Using! Unique 360° valve allows spraying in upright or inverted position. Spray foam in a sweeping motion across cloth, mop or broom. Allow foam to penetrate into fibers. Reapply as needed to attract dust, lint and dirt. Shake out or wash when considerable dust or lint build-up occurs, or if foam will no longer soak in after application.

WATER-BASED DUST MOP TREATMENT
