FIRST AID

Do not use in commercial food/feed handling establishments, restaurants or other areas where food is commercially prepared or

Do not allow adults, children, or pets to enter the treated area until sprays have dried. Do not apply this product in a way that will contact adults, children, or pets, either directly or through drift. Remove pets, birds, and cover fish aquariums before spraying. Do not were atricles to point of runoff or drip. Do not use treated article until spray has dried. Do not use as a space spray. Not for broadcast use on indoor residential surfaces. INDOORS: COCKROACHES (including adult and immature stages of both non-resistant and organophosphate and carbamate resistant strains), ANTS, BOOKILE, BOXELDER MIGH, CENTERDES, CRICKETS, DERNESTIDIS, RIREBARS, FLEAS, PALINETTO BUGS, SILVERISH, SOWBUGS, TICKS AND WATERBUGS: Apply throughly to all areas where these pests crawl and hide, especially in crads and crevices, and hidden areas around sinks and storage areas, behind baseboards, around doors and windows, behind and under refrigerators, cabinets, sinks and storage to the storage areas, behind baseboards, around doors and windows, behind and under refrigerators, cabinets, sinks and storage areas, behind baseboards, around doors and windows, behind and under refrigerators, cabinets, sinks and storage areas.

SPIDERS: Apply along and behind baseboards, to window and door frames, corners, pipes, storage localities, attics, crawlspaces and other areas over which these pests may crawl.

CENTIPEDES, EARWIGS, GROUND BETTLES, MILLIPEDES, MOLE CRICKETS, PILLBUGS, SOWBUGS, SCORPIONS and TICKS: Apply around doors and windows and other places where these pests may enter premises. Treat baseboards, storage areas and other locations where these

CARPET BEELES (BLACK, FURNITURE AND VARIED): Spray on and under edges of floor coverings, under rugs and furniture and in closets or other localities where these insects are found.

STORAGE AND DISPOSAL

Do Not Contaminate Water, Food, or Feed By Storage or Disposal.
