### RED CLOVER TEA ROOM DEODORIZER FEATURES:

Red Clover Tea Room Deodorizer chemically masks malodors. Contains less than 30% total VOC content! This product was developed especially for metered dispensing units that operate on a 15 minute cycle in closed areas where the control of odors is important. Unpleasant odors such as stale smoke, decay, toilet putrescence, cooking, flatulence and many others associated with humans or animals are hunted down and chemically masked by this deodorizer. Millions of very tiny aerosol particles are suspended with each metered spray in restrooms, halls, lounges, offices, schools, locker rooms, etc. One unit is recommended per 6,000 cubic feet of space. Air movement and ventilation rate may vary somewhat. Works in most time dispense machines. Each can has 3,000 sprays.

#### DIRECTIONS:

Remove protective cap and insert in dispenser. Adjust Interval setting to 15 minute, 24/7 for 30-day operation or amend settings as desired. Position dispenser so that the concentrated spray will not directly fall on people, animals, food, beverages, food processing surfaces or solvent-sensitive surfaces including varnished or painted surfaces. NOTE: Time-dispense metered cabinets should be mounted on wall at least 7 feet above the floor and in a location free from furniture, sensitive plastic surfaces or any other objects 3 feet in front of the cabinet. Time-dispensing cabinets are not intended for use by placement on horizontal surfaces such as cabinets, shelves or other finished surfaces. When mounted in small, enclosed areas with little to no exhaust, set dispenser on longest interval setting.
