Although **MARC Big Bad Orange Neutral Cleaner** is designed for use in automatic floor scrubbing machines, it may also be used in manual damp mopping operations.

Although **MARC Big Bad Orange** does not need to be rinsed at the normal use-dilution, when hand mopping, maintenance personnel should pick up the soiled water and change the solution as needed to avoid redistributing soil on the floor.

DIRECTIONS

For normal soil and for autoscrubber use, dilute one part **MARC Big Bad Orange Neutral Floor Cleaner** with approximately 40 parts of water (two to four ounces per gallon of water). Scrub floor with machine, picking up the dirty solution on the floor. If using a hand mop, allow solution to remain on the floor a few minutes and then pick up with a mop or wet vac. Buffing the floor after cleaning will rejuvenate the shine.

For cleaning up heavy soils by damp mopping, dilute one part **MARC Big Bad Orange** with approximately 25 parts of water (four to six ounces per gallon of water). Pick up solution and rinse floor thoroughly with clean water.
