DIRECTIONS

Read all directions and cautions carefully before use.

RING 'B' GONE is specifically designed to remove stubborn toilet bowl rings and other hard water spotting and build-ups in toilets.

NOTE: Wear safety glasses and rubber gloves. Do not contact glass. Use only on toilets. Do not dilute product. Test on an inconspicuous area first. Do not use on colored or tinted bowls. May remove the shine from some porcelain. **Ring 'B' Gone is not recommended for daily housekeeping use, but only for periodic maintenance. Overuse or daily use may cause damage.**

Lower water level to 2 inches below the stained area. Shake container. Using a dry bowl mop or other applicator saturated with Ring 'B' Gone, apply to the stained area. Work on a small area at a time. Allow to set 1 to 2 minutes. Heavy stains may require more contact time or additional applications. Use only the minimum contact time required or etching of the surface may occur. Rinse surface thoroughly with water to remove all residue.

DANGER: Contains ammonium bifluoride. Do not allow to come into contact with eyes, skin or clothing. Do not take internally. Can cause severe burns which may not be immediately visible or painful. Wash thoroughly after handling.

FIRST AID: In case of eye or skin contact, flush **immediately** and thoroughly with large quantities of water for 15 minutes while removing contaminated clothing and shoes. Wash under fingernails. Get medical attention for eyes, and for skin if irritation develops or persists. If swallowed, do not induce vomiting. Give large quantities of water or milk and call a physician at once. Specific antidotal treatment may be required. Do not store product in glass or metal container, or mix with chlorine bleach or other chemicals. Rinse empty container with water before discarding.
