DIRECTIONS FOR USE

Prior to using, always test on an inconspicuous area of carpet or upholstery to determine colorfastness and damage to fiber backing as carpeting quality varies widely, and check when area dries.

FOR FRESH SPILLS: Remove any excess residue remaining. Pull towel from container. Apply opened towel to fresh spills to blot and absorb any excess liquid. Apply towel to any remaining spill in a rubbing motion until removed. Wash hands thoroughly with soap and water.

FOR SPOTS AND STAINS: Pull towel from container. Apply towel to spot/stain in a rubbing motion working from the outside toward the center. Continue to apply as noted above until spot or stain is gone. Wash hands thoroughly with soap and water.

FOR ODOR ELIMINATION: After removal of stain, place a fresh towel over area and moisten with water. Leave for 24 hours so the bacteria in the towel can remove the odor and eliminate unseen organic material.



- 2. Pull towel from center of the roll and thread through "X" on the underside of the lid.




4. Snap hinged cap back into place to ensure towels stay moist.
