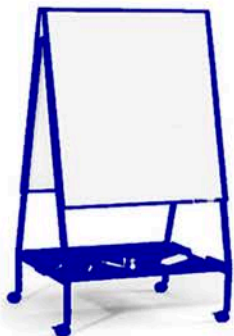

MARC White Board Cleaner quickly and easily removes inks from whiteboards and other dry-erase surfaces such as porcelainized enamel, melamine, "Smart Boards" and "Expo" surfaces. It also removes grease, oil and other contaminants as well as ghosting and shadowing.

DIRECTIONS

Always wear rubber gloves when using **MARC White Board Cleaner**. Use full strength. Erase markings before applying. Apply **MARC White Board Cleaner** to surface, then wipe dry. For very heavy accumulations, allow product to stand on the surface for a few moments before wiping dry. Do not allow product to dry on surface. Repeat if necessary. NOTE: Do not allow product to contact painted, varnished or lacquered surfaces.

DANGER: Contains isopropanol and nonylphenol ethoxylate. Flammable liquid and vapor. Causes eye irritation. May cause skin irritation. May be harmful if swallowed. Keep away from heat, sparks, open flames and other ignition sources. No smoking. Use only non-sparking tools. Take precautionary measures against static discharge. Keep container tightly closed. Wear protective gloves and eye protection. Avoid breathing vapors and mists. Wash skin thoroughly after handling. Use only in a well ventilated area. IF IN EYES: Rinse cautiously with water for several minutes. Remove contact lenses, if present and easy to do so. Continue rinsing. If irritation persists, seek medical attention. IF ON SKIN: Take off immediately all contaminated clothing. Rinse skin with water. If skin irritation or rash occurs, seek medical advice. Wash contaminated clothing before reuse. If inhaled: Remove victim to fresh air and keep at rest in a position comfortable for breathing. IF SWALLOWED: Call a POISON CENTER or seek medical advice if you feel unwell. In case of fire: Use dry sand, dry chemical or alcohol-resistant foam for extinction. Store locked up in a cool, dry, well-ventilated area. Dispose of contents in accordance with all applicable local, regional and national regulations. **KEEP OUT OF REACH OF CHILDREN!**
