## SECTION 2: HAZARDS IDENTIFICATION

CLASSIFICATION: Serious eye irritation, skin irritation.



**SIGNAL WORD AND PRECAUTIONARY STATEMENTS: WARNING:** Causes serious eye irritation. Causes skin irritation. Avoid breathing mist, vapors or spray. Wash skin thoroughly after handling. Use only in a well-ventilated area. Wear protective gloves and eye protection/ face protection. IF IN EYES: Rinse cautiously with water for several minutes. Remove contact lenses, if present and easy to do. Continue rinsing. IF ON SKIN: Wash with plenty of soap and water. Call a POISON CENTER or doctor/ physician if you feel unwell. ## SECTION 4: FIRST AID MEASURES

**EYES:** Rinse cautiously with water for several minutes occasionally lifting the upper and lower eyelids. Check for and remove contact lenses, if present and easy to do. Continue rinsing for at least 20 minutes. Get medical attention.

**SKIN:** Flush contaminated skin with plenty of water. Continue to rinse for at least 20 minutes. Get medical attention. Take off contaminated clothing and wash before reuse. Clean shoes thoroughly before reuse.

**INGESTION:** Wash out mouth with water. Remove dentures if any. Remove victim to fresh air and keep at rest in a position comfortable for breathing. If material has been swallowed and the exposed person is conscious, give small quantities of water to drink. Stop if the exposed person feels sick as vomiting may be dangerous. **DO NOT INDUCE VOMITING** unless directed to do so by medical personnel. If vomiting occurs, the head should be kept low so that vomit does not enter the lungs. Get medical attention if adverse health effects persist or are severe. Never give anything by mouth to and unconscious person. If unconscious, place in recovery position and get medical attention immediately. Maintain an open airway. Loosen tight clothing such as a collar, tie, belt or waistband.

**INHALATION:** Remove victim to fresh air and keep at rest in a position comfortable for breathing. If not breathing, if breathing is irregular or if respiratory arrest occurs, provide artificial respiration or oxygen by trained personnel. It may be dangerous to the person providing aid to give mouth-to-mouth resuscitation. Get medical attention if adverse health effects persist or are severe. If unconscious, place in recovery position and get medical attention immediately. Maintain an open airway. Loosen tight clothing such as a collar, tie, belt or waistband. In case of inhalation of decomposition products in a fire, symptoms may be delayed. The exposed person may need to be kept under medical surveillance for 48 hours.

**METHODS AND MATERIALS FOR CONTAINMENT AND CLEANUP: SPILL:** Stop leak if without risk. Move containers from spill area. Prevent entry into sewers, water courses, basements or confined areas. Wash spillages into an effluent treatment plant or proceed as follows. Contain and collect spillage with non-combustible, absorbent material e.g. sand, earth, vermiculite or diatomaceous earth and place in container for disposal according to local regulations (See Section 13).
